2. The Promotion is purely on notional basis, meaning that no financial arrears will be admissible to them for the period between the date on which they get the benefit of notional promotion and the date on which they have assumed the charge of such promoted post.

3. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month from the date of this Order. They may further note that no request for condonation of delay in exercising the option shall be entertained.

4. The officers who have already been given the benefit of 1st / 2nd /3rd financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.

5. The jurisdictional Principal Commissioner/Commissioner/Pr. Additional Director General/Additional Director General shall ensure that if any of the officer(s) whose name has figured in the table above is under suspension or facing any charge sheet or prosecution or undergoing penalty should not be allowed to assume charge of the post of Inspector and this fact shall be reported to this office immediately.

6. The promotion of officers who are currently on deputation/loan to other agencies/formations/SEZs (outside of Bhopal zone cadre controlling authority) shall take effect only after they are repatriated to Bhopal zone and report to their respective place of posting immediately and not later than 12.06.2026 for joining the promotional post.

7. The promotion ordered now in subject to the condition that the officers shall join latest by 12.06.2026. In case the officer is not willing to assume charge of the promotional post, a formal refusal letter must be submitted to the concerned Commissionerate, which shall in turn intimate this office immediately. All consequences arising as a result of non-acceptance of promotion in terms of DP & AR OM No. 1/3/69-Estt(D) dated 22-11-75 as amended by DP & AR OM No. 22034/3/81-Estt(D) dated 1.10.1981 and DP & AR OM No. 22011/6/75-Estt(D) dated 30.12.1976 shall follow:

(i) No fresh offer of appointment shall be made to him for him for a period of one year or till a next vacancy arises whichever is later.

(ii) On eventual promotion to the grade of Inspector, he will lose seniority vis-à-vis his junior promoted earlier.

(iii) As per DOPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009, the officer shall not be considered for further financial up-gradation till he agrees to be considered for promotion again and the next financial up-gradation shall also be differed to extent of period of debarment due to refusal.

8. On promotion, the following transfers and postings in the grade of Inspector of CGST & Central Excise, Bhopal Cadre Control Zone is hereby ordered with immediate effect and till further orders:-
