2. आईसीटी स्थानांतरण आदेश संख्या ई.ओ. संख्या 02/2026 दिनांक 27.03.2026 और ई.ओ. संख्या 06/2026 दिनांक 13.04.2026 के तहत सीजीएसटी रायपुर में स्थानांतरित किए गए अधिकारी अपने पदस्थापन पर तुरंत कार्यभार ग्रहण करेंगे। स्थानांतरण/रोटेशन आदेश के तहत नियुक्त अधिकारियों को कार्यभार सौंपते और ग्रहण करते समय विधिवत कार्यभार ग्रहण करना चाहिए। सभी अत्यावश्यक और समयबद्ध मामलों की सूची तैयार करके उसकी एक प्रति कार्यभार ग्रहण करने वाले अधिकारी को सौंप देनी चाहिए। महत्वपूर्ण कार्यों की सूची विभाग एवं प्रौद्योगिकी विभाग के कार्यालय ज्ञापन संख्या 13024/01/2014-प्रशिक्षण (प्रशिक्षण संदर्भ) दिनांक 26.09.2014 के अनुसार तैयार करके उत्तराधिकारी को सौंप देनी चाहिए। / The officers who are transferred to CGST Raipur under ICT transfer Order No. E.O. No. 02/2026 dated 27.03.2026 and E.O. No. 06/2026 dated 13.04.2026 shall join their place of posting immediately. The officers under order of transfer/rotation should hand over and take over the charges properly at the time of relieving and joining from their place of posting. The list of all urgent and time bound matters, should be prepared and copy of the same be handed over to the officer taking over the charges. Note of

important work be prepared as per DoPT Office Memorandum No. 13024/01/2014-Trg. (Trg. Ref) dated 26.09.2014 and handed over to the successors.

3. अधिकारियों के नए पदस्थापन स्थान पर कार्यभार ग्रहण करने से पहले किसी भी अभ्यावेदन पर विचार नहीं किया जाएगा। उचित माध्यम से अधिकारियों के किसी भी अभ्यावेदन पर नए पदस्थापन स्थान पर कार्यभार ग्रहण करने के बाद ही विचार किया जाएगा। / No representation whatsoever shall be entertained before the officers join at their new place of posting. Any representation from the officers through proper channel will be entertained only after joining in new place of posting.

4. अधिकारियों के स्थानांतरण/प्रतिधारण/रोटेशन के संबंध में अब तक प्राप्त सभी अभ्यावेदनों का निस्तारण कर दिया गया है। All the representations of the officers for transfer/retention/rotation received till date have been disposed.

5. यदि कोई प्रभार बिना किसी अधिकारी के छोड़ दिया जाता है तो कार्यालय के सुचारू संचालन के लिए क्षेत्राधिकारी सहायक आयुक्त उप-आयुक्त उसे मौजूदा अधिकारी को आवंटित कर सकते हैं। उपर्युक्त सभी अधिकारियों को अपने नए पदस्थापन स्थान पर तत्काल कार्यभार ग्रहण करना चाहिए। / In the case any charge is left unattended without any officer, the jurisdictional Assistant/ Deputy Commissioner may allocate the same to the existing officer for smooth functioning of the office.
