2. The above officers may exercise their option for pay fixation under the provisions of Rule F.R. 22(I)(a)(1) within one month from the date of issuance of this order. The officers will not be eligible for grant of arrears of pay for the notional period of promotion. However, they shall be eligible for pay fixation benefits with effect from date of notional promotion.

3. The officers mentioned at Sr. No. 14 (Smt. Ragini Kumari) & Sr. No. 15 (Shri Anil Kumar Kanwar) should join their new post latest by **10.04.2017**. If they fail to join their duties by the said date, it will be treated as their refusal to accept promotion and accordingly, their promotion order will be cancelled without any further notice.

4. Consequent upon the promotion/notional promotion, all the above officers are retained in their present place of posting.

5. The seniority of the above officers in the grade of Stenographer Grade-I will be fixed as per the select panel drawn by the Review DPC held on 29.03.2017 and as per the instructions and guidelines in force.
