The seniority of the Smt.Meena Chouhan will be fixed just below Shri S.S.Gajbhiye (Sl.No.6) and seniority of Shri Hariom Pandit will be fixed just below Smt.Meena Chouhan and above Smt.Aruna Manohar (Sl.No.7) in the combined seniority list of Deputy Office Superintendent of Central Excise, Bhopal Zone as on 01.01.2014.
03. The officers who have already been given the benefit of 1st / 2nd Financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
04. The above promotion is subject to the outcome of W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No.960/2011 in the case of Sanjay Pathak Vs.UOI pending with CAT Jabalpur and various cases pending with different forum.
05. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
06. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Deputy Office Superintendent and this fact should be reported to this office immediately.

07. The seniority position of above promoted officers in the seniority list of Deputy Office Superintendent will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
