02. The officers who have already been given the benefit of 1st/2nd/3rd Financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.

03. The promotion of the officers mentioned above shall be on in-situ basis, till the time their posting orders are issued. The above promotions does not confer any right upon them to be retained at their present place of posting at later date when subsequent posting is decided.

04. The above officers should join their new post latest by 24/11/2017. If they fail to join their duties by the said date, it will be treated as their refusal to accept promotion and accordingly, their promotion order will be cancelled without any further notice. Consequently, they will not be considered for promotion in terms of Para 3 of O.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.

05. The above promotion is subject to the outcome of decisions pending in various judicial fora.
06. Under the provisions of FR 22(1)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
07. The seniority position of above promoted officers in the seniority list of Inspector will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
08. The Principal Commissioner/Commissioner concerned shall ensure that if any of the officers whose name has figured in table above to this order is/are not cleared from vigilance angle, he/she should not be posted to a sensitive charge as per vigilance policy.
09. All the officers should ensure proper take over and hand over of charge. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014
10. Consequent upon promotion, all the promoted officer are nominated and directed to attend 'Induction Course for Inspectors', conducted by NACIN, Bhopal, scheduled to be held from 28.11.2017 to 19.01.2018 at Atal Bihari Vajpayee Institute of Good Governance & Policy Analysis, Sushasan Bhawan, Bhadbhada Road, T.T. Nagar, Bhopal - 462003. The respective Pr. Commissioner/Commissioners is requested to relieve the above said officers for 'Induction Course'.
11. The respective Commissioners are requested to submit a consolidated joining/relieving report of the above officers to this office by 30.11.2017.
12. This issues with the approval of Chief Commissioner, Central Excise Bhopal Zone.
