3. The financial up gradation granted to the above officials are subject to, inter-alia, the following condition:-

3.1 The financial up-gradation will not result in change in the designation of the beneficiaries i.e. the grade is granted with the retention of their old designation and the said financial up-gradation shall not be correlated to higher status.

3.2 The financial up-gradation under the MACP Scheme shall be purely personal to the incumbents (officials) and shall not amount to actual functional promotions of the officials concerned. It shall have no relevance to their inter-se seniority position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior officials have got higher pay scale(s) under the MACP Scheme. The concept of "Senior-Junior" is alien to the idea behind the MACP Scheme.

3.3 Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up gradation under the Scheme. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same Pay matrix level/Grade pay as granted under

MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher Pay matrix level/ Grade pay than what is available under MACPS, no pay fixation would be available and if no such cell is available in the pay matrix level to which promoted, he/she shall be placed at the next higher cell in that level/only difference of grade pay would be made available. The employee may have an option to get this fixation done either on the date of upgradation or w.e.f. the date of next increment as per the option to be exercised by him/her.

3.4 On their financial up-gradation under the MACP Scheme, which may not involve assumption of higher duties and responsibilities, as a special dispensation, their pay shall be fixed under F.R. 22(I) (a)(1) to get their pay fixed in the higher post/Pay matrix level/grade pay either from the date of their promotion /upgradation or from the date of their next increment viz. 1st July or 1st January, as the case may be, of the year. The pay and the date of increment would be fixed in accordance with clarification issued by the Department of Expenditure from time to time.

4. Under the provisions of FR 22(I)(a)(1), the beneficiaries have to exercise their option for fixation of pay within one month from the date of issuance of this order or within one month from the due date of eligibility if due date of MACP in future. They may further note that no request for condonation of delay in exercising the option shall be entertained.

5. The Pr. Commissioner/Commissioner shall ensure that if any of the officer whose name has figured in the table above is under suspension or facing any charge sheet or prosecution or undergoing penalty on the due date of financial upgradation mentioned against his/her name, he/she should not be allowed aforesaid financial upgradation and this fact should be reported to this office immediately.

6. This issues with the approval of the Chief Commissioner, CGST, Central Excise & Customs, Bhopal Zone.
