कर्मचारी चयन आयोग द्वारा आयोजित संयुक्त स्नातक स्तरीय परीक्षा, 2025 के परिणाम के आधार पर केन्द्रीय अप्रत्यक्ष कर एवं सीमा शुल्क बोर्ड (सीबीआईसी), नई दिल्ली द्वारा निरीक्षक (वस्तु और सेवा कर तथा केन्द्रीय उत्पाद शुल्क) के पद हेतु अनुशंसित 58 अभ्यर्थियों का आबंटन इस निर्देश के साथ किया गया है कि नियुक्ति प्रस्ताव जारी किए जाने से पूर्व निर्धारित प्रक्रिया के अनुसार सभी आवश्यक औपचारिकताएँ एवं अपेक्षित आवश्यकताएँ पूर्ण कर ली जाएँ।

The Central Board of Indirect Taxes and Customs (CBIC), New Delhi has allocated 58 candidates recommended by the Staff Selection Commission on the basis of the results of the Combined Graduate Level Examination, 2025 for the posts of Inspector, CGST and Central Excise with instructions to complete all necessary formalities /requirements, as per the prescribed procedure before the offers of appointment are issued.

3. इस संबंध में, अनुलग्नक-1 में सूचीबद्ध अभ्यर्थियों को निर्देशित किया जाता है कि वे दिनांक 23.07.2026 को प्रातः 09:30 बजे **जीएसटी एवं केंद्रीय उत्पाद शुल्क के मुख्य आयुक्त का कार्यालय, 35-सी, जी.एस.टी. भवन, प्रशासनिक क्षेत्र, अरेरा हिल्स, भोपाल-462011** में दस्तावेज़ सत्यापन हेतु उपस्थित हों। शारीरिक क्षमता परीक्षण (Physical Endurance Test - PET) दिनांक 24.07.2026 को आयोजित किया जाएगा। शारीरिक क्षमता परीक्षण के आयोजन स्थल एवं समय की सूचना अभ्यर्थियों को पृथक रूप से प्रदान की जाएगी। अभ्यर्थियों से अनुरोध है कि वे उपरोक्त हेतु उपयुक्त खेल-कूद के जूते (Sports Shoes) साथ लेकर आएँ।

The Physical Endurance Test (PET) will be conducted on **24.07.2026**. The venue and reporting time for the Physical Endurance Test will be communicated separately. Candidates are advised to bring suitable sports shoes for the above Test.
