- 02. The above Officers should join the promoted post latest by 15.01.2022 failing which it will be treated that the officer has not accepted the promotion and all consequences arising as a result of non-acceptance of promotion in terms of DP & AR OM No. 1/3/69-Estt(D) dated 22.11.75 as amended by DP & AR OM No. 22034/3/81-Estt(D) dated 01.10.1981 and DP & AR OM No. 22011/6/75-Estt(D) dated 30.12.1976 shall follow:
  - (I) No fresh offer of appointment shall be made to him/her for a period of one year or till a next vacancy arises whichever is later.
  - (II) On eventual promotion to the grade of Lower Division Clerk, he/she will lose seniority vis-à-vis her junior prompted earlier.
  - (III) As per DOPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009, the officer shall not be considered for further financial upgradation till he/she agrees to be considered for promotion again and the next financial upgradation shall also be differed to extent of period of debarment due to refusal.
- 03. The above promotion will be subject to the outcome of various cases pending before different judicial forum.
- 04. The officers, if already been given the benefit of 1st /2nd /3rd financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.

- 05. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
- The Commissioner's concerned shall ensure that if any officer is under suspension or facing 06. any charge sheet or prosecution, he/she should not be allowed to assume charge of Lower Division Clerk and this fact should be reported to this office immediately.
- 07. The promotion of officers who are currently on deputation/loan to other agencies/formations/SEZs shall take effect only after they are repatriated to their parent CGST, Customs & Central Excise Zone and repot to their respective Commissioner's office immediately and not later than 15.01.2022 for joining the promotional post.
- 08. The posting of the officers promoted on in-situ basis is provisional. The above promotion deoes not confer any right upon them to retain at their present place of posting.
- 09. Necessary compliance report regarding their joining should be sent to this office by 20.01.2022.
