## ESTABLISHMENT ORDER NO.66 /2021

**Shri. Ramesh Prasad Soni,** Staff Car Driver Grade-II of CGST, Central Excise & Customs, Bhopal Zone is hereby promoted to the grade of Staff Car Driver Grade-I in level 5 with Pay Matrix of Rs. 29,200–92,300/- with effect from 01.01.2022 or from the date of joining on the promoted post whichever is later.

- 02. The officer if already extended the benefit of  $1^{st}$  /  $2^{nd}$  / $3^{rd}$  financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
- 03. The above promotion will be subject to the outcome of various cases pending before different judicial forum.
- 04. Under the provisions of FR 22(I)(a)(1), the promoted officer has to exercise his option for fixation of pay within one month of his promotion. He may further note that no request for condonation of delay in exercising the option shall be entertained.
- 05. The Commissioenrate concerned shall ensure that if the officer is under suspension or facing any charge sheet or prosecution, he should not be allowed to join the post of Staff Car Driver Grade-I and this fact should be reported to this office immediately.
- O6. The promotion ordered now is subject to the condition that the officer shall join latest by 15.01.2022 failing which it will be treated that the officer has not accepted the promotion and all consequences arising as a result of non acceptance of promotion in terms of DP& AR OM No. 1/3/69-Estt(D) dated 22-11-75 as amended by DP 7 AR OM No. 22034/3/81-Estt(D) dated 1.10.1981 and DP & AR OM No. 22011/6/75-Estt(D) dated 30.12.1976 shall follow:
  - (I) No fresh offer of appointment shall be made to him for a period of one year or till a next vacancy arises whichever is later.
  - (II) On eventual promotion to the grade of Staff Car Driver Grade-I , He will lose seniority vis-à-vis his junior prompted earlier.
  - (III) As per DOPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009, the officer shall not be considered for further financial upgradation till he agrees to be considered for promotion again and the next financial upgradation shall also be differed to extent of period of debarment due to refusal.



- 07. On promotion Shri. Ramesh Prasad Soni is posted to Raipur CGST Commissionerate.
- O8. Necessary compliance report regarding his joining should be sent to this office latest by **20.01.2022**.
