2. The promotion to the grade of Administrative Officer of CGST, Central Excise & Customs is made purely on ad-hoc basis and does not confer any right on the officers so promoted for any claim for continued officiating or regular promotion in the grade of Administrative Officer of CGST, Central Excise & Customs and the period of such service shall not count for seniority or as a qualifying service for further promotion. The Competant Authority reserves the right to terminate the ad-hoc promotion and revert the officer(s) to the post from which he/she was promoted.

3. The ad-hoc promotions shall be subject to the decision of the competent authority for regular promotion.

4. The officers who have already been given the benefit of financial upgradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.

5. The jurisdictional Principal Commissioner/Commissioner/Pr. Additional Director General/Additional Director General shall ensure that if any of the officer(s) whose name has figured in the table above is under suspension or facing any charge sheet or prosecution or undergoing penalty should not be allowed to assume charge of the post of Administrative Officer and this fact shall be reported to this office immediately.

6. The promotion ordered is subject to the condition that the officer shall join the promotional post **on or before 01.05.2026**. In case the officer is not willing to assume charge of the promotional post, a formal refusal letter must be submitted to the concerned Commissionerate, which shall in turn intimate this office immediately.

7. The promotion of officers who are currently posted on deputation/loan/rotation basis to other Directorates/SEZs/formations shall take effect only after they are repatriated to their **new posting place** for joining the promotional post not later than **01.05.2026**.
