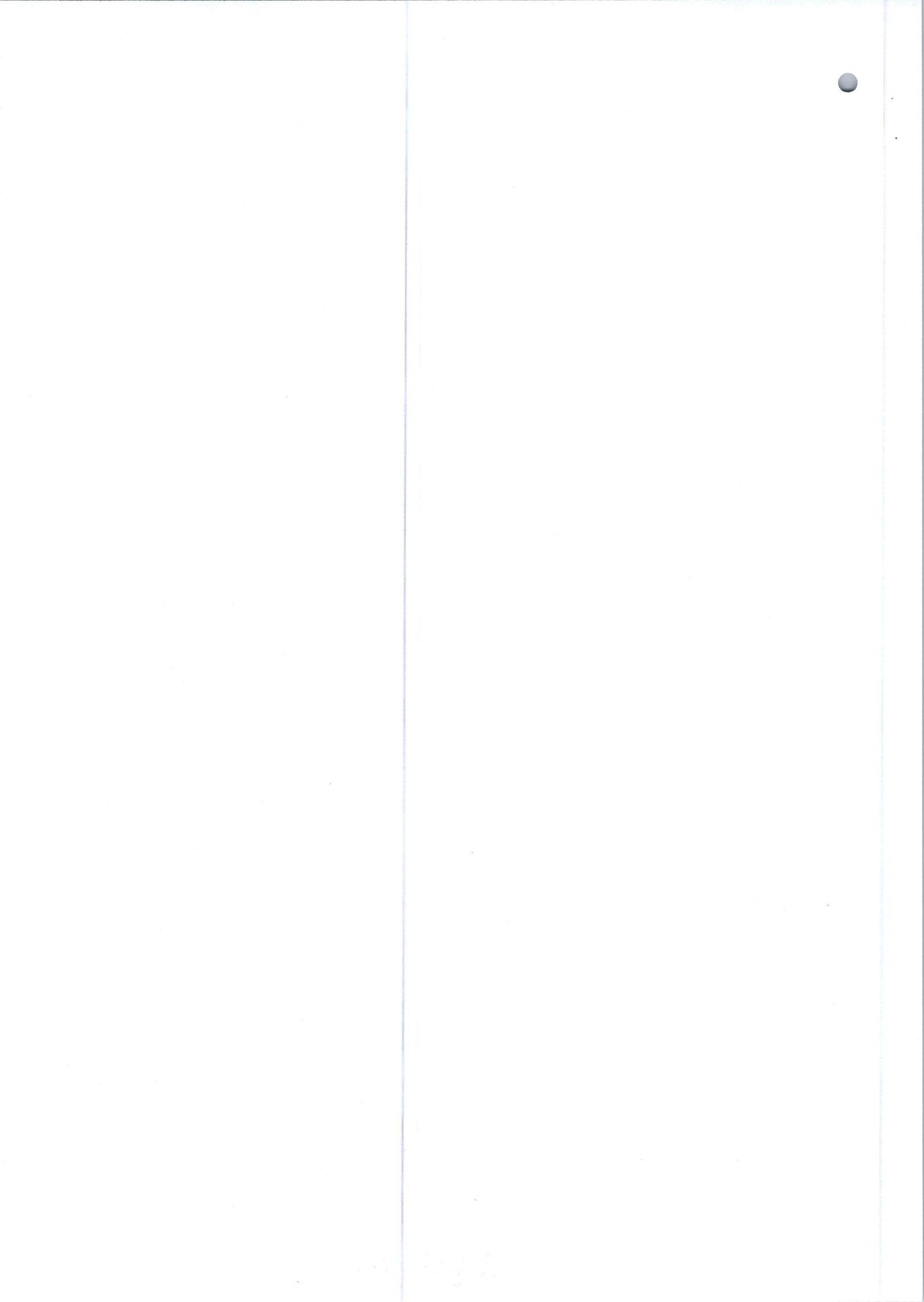

प्रभार में सभी महत्वपूर्ण एवं समयबद्ध कार्यों की एक सूची तैयार करें और उसे नियंत्रण अधिकारी को सौंपें, जिसकी एक प्रति प्रभार ग्रहण करने वाले अधिकारी को भी उपलब्ध कराई जाए। प्रभार सौंपने वाले अधिकारी को DoP&T कार्यालय ज्ञापन सं. 13024/01/2014-TRG (Trg-Ref) दिनांक 26.09.2014 के अनुसार, प्रभार ग्रहण करने वाले अधिकारी के लिए एक संक्षिप्त टिप्पणी (हैंडओवर नोट) भी तैयार करनी होगी।/ All the officers mentioned above, who have been transferred/rotated, must be relieved mandatorily by 17.04.2026. The transferred officers are directed to prepare a list of all important and time-bound tasks under their charge and hand it over to the controlling officer, with a copy to be provided to the officer taking over the charge. The officer handing over the charge shall also prepare a brief note (handover note) for the officer taking over the charge, in accordance with DoP&T Office Memorandum No. 13024/01/2014-TRG (Trg-Ref) dated 26.09.2014.
