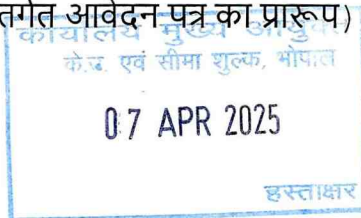

**Brief facts of the case:**

1. The Appellant has filed offline RTI Application dated 31.01.2025 received on 12.02.2025 in this office wherein she had sought the following information:

- i. *Copies of Physical Endurance Test result sheets conducted during the years 2011,2012,2013,2014 and 2015 in context of promotions to the grade of Inspector.*
- ii. *Copy of Promotion Order of Sh. Jay Kumar Ambhore to the grade of Inspector.*
- iii. *Copy of promotion order of Ms. Divya Patni (now Supdt) to the grade of Inspector.*
- iv. *Copy of Medical certificate of Ms. Aarti Parshar issued by the District Medical Board/Civil Surgeon, Jabalpur pertaining to year 2012 and 2014.*

2. With reference to the information sought vide above RTI Application, the Appellant was provided copies of the following documents by the Respondent/CPIO vide letter dated 11.03.2025:

- i. *Copies of the following physical endurance test result sheets:*
  - a. *Copy of physical endurance test result sheet held on 22.01.2015 (for promotion to the grade of Inspector)*
  - b. *Copy of physical endurance test conducted on 20.01.2015 at Jabalpur.*
  - c. *Copy of physical endurance test conducted on 20.01.2015 at Bhopal Commissionerate.*
  - d. *Copy of physical endurance test conducted on 22.01.2015.*
  - e. *Copy of physical endurance test conducted on 22.01.2015 at Nagpur.*
  - f. *Copy of physical endurance test conducted on 20.01.2015 at Hqrs, Indore.*
  - g. *Copy of physical endurance test conducted on 30.09.2014 at Nagpur.*
  - h. *Copy of physical endurance test conducted on 21.04.2014.*
  - i. *Copy of physical endurance test conducted on 21.04.2014 at Hqrs, Indore.*
  - j. *Copy of physical endurance test conducted on 23.04.2013 at Raipur Commissionerate.*
  - k. *Copy of physical endurance test result sheet dated 25.04.2014 at Nagpur.*
  - l. *Copy of physical endurance test result sheet conducted on 27.01.2015 at Jabalpur.*
- ii. *Copy of Establishment Order No. 38/2014 dated 30.10.2014 with respect to promotion of Jay Kumar Ambhore to the grade of Inspector.*
- iii. *Copy of Establishment Order No. 39/2014 dated 30.10.2014 with respect to promotion of Divya Patni to the grade of Inspector.*
- iv. *Copy of Medical Health Certificate dated 05.11.2014 issued by the Office of Civil Surgeon, Jabalpur.*

**Grounds of appeal:**

3.1. The Appellant felt that the CPIO has not provided the details requested by her vide RTI Application dated 31.01.2025 received on 12.02.2025.

3.2 Being unsatisfied with the reply dated 11.03.2025 given by the CPIO, the Appellant has filed instant Appeal dated 04.04.2025 (received in this office on 07.04.2025) on the ground that copies of all the physical endurance test sheets (for the year 2012, 2013 and 2014) have not been

provided. Further, the Appellant has requested specifically for the following information:

- a. Copies of physical endurance test results for the year 2012, 2013 and 2014 with respect to the candidature of the Appellant for promotion to the grade of Inspector.
- b. Copy of the Medical Certificate issued by District Medical Board/Civil Surgeon, Jabalpur during April, 2012.

**Reply of the CPIO, CCO Bhopal in response to the instant Appeal:**

4. Comments were sought from the CPIO, CCO Bhopal on the Appeal filed by the Appellant. The CPIO, CCO Bhopal, vide letter dated 29.04.2025 has submitted as under:

*All the relevant information available has already been provided to the appellant. Further, if the appellant seeks to obtain any other document then she may inspect the relevant files by visiting the office with prior intimation.*

**Discussion & Findings:**

5. I have carefully gone through the grounds of Appeal filed by the Appellant and the comments submitted by the CPIO on the Appeal, as mentioned above.

6. I find that the Appellant, vide her RTI Application dated 12.02.2025, had requested for copies of result sheets of Physical Endurance Test (PET) conducted during the years 2011 to 2015 in context of promotions to the grade of Inspector. She has further asked for copies of Promotion Orders of Sh. Jay Kumar Ambhore and Ms. Divya Patni (now Superintendent) to the grade of Inspector. She has also requested for copies of her Medical certificates issued by the District Medical Board/Civil Surgeon, Jabalpur pertaining to years 2012 and 2014.

7. I find that the CPIO, vide his reply dated 11.03.2025, has provided copies of all 12 result sheets of PET conducted during the years 2011 to 2015, as available. The CPIO has also provided copies of promotion orders of Sh. Jay Kumar Ambhore and Ms. Divya Patni (now Supdt) to the grade of Inspector. Further, the CPIO has provided copy of Medical Health Certificate dated 05.11.2014 issued by the Office of Civil Surgeon, Jabalpur to the Appellant.

8. I find that the Appellant has contested that the CPIO has not provided her the copies of all the PET result sheets for the year 2012, 2013 and 2014. She has now requested for copies of PET result sheets for the year 2012, 2013 and 2014 with respect to her candidature for promotion to the grade of Inspector and copy of the Medical Certificate issued by District Medical Board/Civil Surgeon, Jabalpur during April, 2012. On the instant Appeal filed by the Appellant, the CPIO has submitted that all the relevant information available has already been provided and that if the appellant seeks to obtain any other document then she may inspect the relevant files by visiting the office with prior intimation.

9. With reference to copies of PET result sheets, I find that the Appellant has emphasized in the instant Appeal that she may be provided with the copies of PET result sheets for the year 2012, 2013 and 2014 with respect to her candidature for promotion to the grade of Inspector, specifically. Since the Appellant did not specify the same in her RTI Application dated 12.02.2025, she cannot seek any additional information by way of an Appeal to the RTI Application.

10. Further, on examination of the RTI Application dated 12.02.2025 and reply dated 11.03.2025 given by the CPIO to the Appellant, I find that the Appellant has requested for quite an old record and that the CPIO has already provided all the available information to the Appellant. Therefore, I do not find any infirmity in the reply dated 11.03.2025 given by the CPIO to the Appellant.

11. On the basis of facts before me, I proceed to decide the Appeal. In view of the above, I pass the following order:

**Order**

I do not find any infirmity in the reply dated 11.03.2025 given by the CPIO to the Appellant against her RTI Application dated 31.01.2025 received on 12.02.2025. Further, if the Appellant seeks to obtain any other document then she may be allowed to inspect the relevant files by visiting the office during official hours with prior intimation within 15 days of receipt of this order.

12. The RTI Appeal dated 07.04.2025 filed by Appellant is accordingly disposed off in the above terms.
