**02.** Under the provisions of FR 22(I)(a)(1), the promoted officer has to exercise his/her option for fixation of pay within one month of his/her promotion. He/She may further note that no request for condonation of delay in exercising the option shall be entertained.

**03.** The officer(s) who have already been given the benefit of 1st / 2<sup>nd</sup>/3<sup>rd</sup> Financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.

**04.** The above officers should join their duties in new post latest by **12.06.2017**. If He/She fails to join her duty by the said date, it will be treated as her refusal to accept promotion and accordingly, his/her promotion order will be cancelled without any further notice. Consequently, he/she will not be considered for promotion in terms of Para 3 of O.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.

**05.** Consequent upon the promotion, all the above officers are retained in their present place of posting, with the approval of the competent authority.

**06.** Notwithstanding anything contained in point 05 above, the promoted officers who have been working on deputation to Directorates/other departments are required to join their parent Commissionerate latest by **12.06.2017** and their promotion to the grade of Executive Assistant shall be reckoned from such date of joining only.

**07.** The respective Commissioners are requested to submit a consolidated joining/relieving report of the above officers to this office by **20.06.2017**.
