- 02. The officers who have already been given the benefit of 1st / 2nd /3rd financial upgradation under ACP/MACP Scheme to the Pay Matrix Level 8 will not be entitled for the pay fixation benefit.
- 03. The above promotions are subject to the decision of the Hon'ble Supreme Court in the case of Jarnail Singh Vs. Lacchmi Narain Gupta and other various cases pending in different judicial fora including W.P.C.T. No. 261/2008 filed by Samiran Roy & Ors. vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court.
- 04. The promotions are also subject to the decision of the Hon'ble High Court of Madhya Pradesh, Jabalpur in the Misc. Petitions No. 2570/2023, 4585/2023, 4588/2023, 3106/2023 and 3372/2023 filed by Chinmay Dwivedi and others.

- 05. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
- 06. The Pr. Commissioner/Commissioner concerned shall ensure that if any of the officers whose name has figured in the table above is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.
- 07. The posting of the officers promoted on in-situ basis is provisional. The above promotions do not confer any right upon them to be retained at their present place of posting.
- 08. The promotion of the officers who are currently posted on deputation to other agencies/ formations/SEZs or on loan basis to other agencies/formations outside the Zone shall take effect only after they are repatriated to their parent CGST, Central Excise and Customs Zone immediately and not later than 8.1.2024 for joining the promotional post.
- 09. The promotion ordered now is subject to the condition that the officers shall join latest by 8.1.2024 failing which it will be treated that the officer has not accepted the promotion and all consequences arising as a result of non acceptance of promotion in terms of DP& AR OM No. 1/3/69-Estt(D) dated 22-11-75 as amended by DP & AR OM No. 22034/3/81-Estt(D) dated 1.10.1981 and DP & AR OM No. 22011/6/75-Estt(D) dated 30.12.1976 shall follow:
 - (i) No fresh offer of appointment shall be made to him/her for a period of one year or till a next vacancy arises whichever is later.
 - (ii) On eventual promotion to the grade of Superintendent, he/she will lose seniority vis-à-vis his junior promoted earlier.
 - (iii) As per DOPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009, the officer shall not be considered for further financial up-gradation till he/she agrees to be considered for promotion again and the next financial up-gradation shall also be differed to the extent of period of debarment due to refusal.
